

Are you selling your fund to retail investors in the EU/EEA?

If you are, you are most likely in scope of the PRIIPs Regulation already if you are an AIF, or you will be in scope starting from 1 January 2023 if you are a UCITS. With the new rules entering into force on 1 January 2023, you will be required to:



Produce a PRIIPs KID

for each class of units that is made available to retail investors within the EU/EEA in line with the new content and format rules which apply from 1 January 2023. Existing PRIIPs KIDs will also need to be reviewed and revised accordingly.



Translate the PRIIPs KID

into one of the official languages, or a language accepted by the national competent authority, of each EU member state where the class of units is made available to retail investors.

Monitor the accuracy of all PRIIPs KIDs and their underlying data

on an annual, and potentially monthly basis, depending on your fund type, to ensure that the PRIIPs KID and its supporting documents are accurate, compliant and up to date.

Produce and publish past performance documents

which have to be updated annually. Category 2 products, such as UCITS, will almost always be subject to the requirement to produce, publish and update past performance documents.

Produce, update and publish previous performance scenarios

on a monthly basis. Category 2 products, which are required to publish past performance documents, will also be required to publish previous performance scenarios on the PRIIPs Manufacturer's website.



Technical Description

1 Onboarding

Our web-based portal allows you to easily mandate us, at any time, with the production of your PRIIPs KIDs. You will then be able to onboard the relevant classes directly onto our platform where you can upload all the necessary information, ISIN and documents, while having access to our experienced analysts via our embedded chat function. We automatically source all the relevant historic data we need through the onboarded ISIN. For products without an ISIN, we will source data based on our internal library of peer funds and performance simulation methodologies.

Narratives

Using our natural language processing algorithm, we will generate the narratives of the PRIIPs KID based on the fund prospectus you have uploaded during the onboarding process. Any narratives which are dependant on the calculation will be completed automatically simultaneously to the calculation of the quantitative sections. Our regulatory experts perform quality checks on each draft PRIIPs KID before it is released to you for validation.

Quantitative

Category-specific calculation engines are embedded into our platform and ensure the calculation of all required figures and graphs. Our models and libraries cater for Category 1, 2 and 3 products, including illiquid funds, UCITS and structured products.

Among others, our calculations are based on:

- ✓ proprietary J-Curve model simulating capital call and distribution cash flows for PRIIPS where no methodology has been described (Category 1)
- ✓ Time-series forecasting models in line with Category 2 requirements featuring an integrated financial data feed
- ✓ Integrated simulation models in line with Category 3 requirements incl. in house volatility surface models.

Our in-built validation workflow includes quality control by our regulatory experts and allows you to appoint an intermediary validation step, such as by your legal advisor, before being sent to you for final approval.

4 Supplementary documents

In addition to the PRIIPs KID, you may be required, depending on the type of fund, or requested by third parties, to provide certain supplementary documents. Our solution accommodates for all these requirements and requests, meaning we will generate, for each validated PRIIPs KID:

- ✓ A separate past performance document
- Previous performance scenario calculations, including monthly updates
- Translations of the PRIIPs KID and the past performance document*
- ✓ Completed European PRIIPs template (EPT)
- ✓ Export of audit trail evidencing the validation workflow

5 Monitoring

In accordance with regulatory requirements, PRIIPs KIDs and supplementary documents must be monitored and updated on a regular basis. For most funds, including UCITS, this monitoring must be conducted monthly. Our solution monitors all regulatory thresholds and automatically performs monthly and annual updates in line with regulatory requirements.

During the monitoring, the solution will check and alert you to:

- ✓ Changes to the SRI
- ✓ Changes to performance scenarios beyond certain thresholds

Our platform will also automatically update the previous performance scenario calculations each month and it will initiate the annual update of the PRIIPs KID and its supplementary documents.

*Currently available languages are German, French, Italian, Spanish and Polish. Where a language is not available yet at the time of production, we will arrange for the translation, free of charge, into any official language of the relevant EU member state.

Once all documents have been generated and validated, you will have unlimited, on-demand access to all your current and previous documents, including their historical versions.

Security


